For a Warranty Period of Fifty (50) years beginning on the Date of Purchase, Amrize Building Envelope LLC, an Indiana limited liability company ("Amrize"), warrants to the Building Owner ("Owner") named above that the GacoFlex™ GacoRoof™ Coating (GR16 Series) purchased by Owner and properly registered for this Building (the "Coating") meets the specifications listed on the GacoRoof Product Data Sheet.

TERMS, CONDITIONS, AND LIMITATIONS

Notice. In the event of a claim, Owner must give written notice to Amrize Warranty Services ("Warranty Services") at the address below. Notification must include a description of the nature of the claim and a copy of Owner's original purchase receipt for the Coating. When required by Amrize, Owner must submit three (3) 12" x 12" samples of the installed Coating selected as follows: two samples must be taken from the suspected area and one sample must be from another area. The costs related to removal of the samples are not included in this Limited Warranty. Amrize will have no obligation under this Limited Warranty if Owner fails to give proper notice to Warranty Services as set forth herein. Notifying a contractor, a re-seller, or an authorized Gaco sales representative is not notice to Warranty Services as required by this section.

Replacement Product. In the event that Amrize determines the Coating does not meet the specifications listed on the Product Data Sheet published by Amrize at the time of purchase, Owner's sole and exclusive remedy and Amrize's total liability shall be limited to providing product sufficient to replace the non-conforming product.

Limitation. For the first year following the Date of Purchase, Amrize will provide replacement product to replace non-conforming product without a reduction for use and thereafter will provide replacement product on a prorated yearly basis. Amrize's obligation over the life of this Limited Warranty is limited to Owner's original purchase price of the Coating.

Non-Assignability. This Limited Warranty is not transferable or assignable in any manner and Amrize precludes Owner from claiming, representing, or implying that this Limited Warranty extends to or is available to anyone other than the Building Owner named above.

Term. The term of this Limited Warranty shall be for the Warranty Period set forth herein and shall not be extended under any circumstances without Amrize's written approval.

Products Not Covered. This Limited Warranty only covers the GacoRoof Coating, and does not cover other products, including but not limited to flashings, adhesives, primers, sealants, base coats, or surfacing.

Disputes. Any dispute, controversy, or claim between Owner and Amrize concerning this Limited Warranty, or relating to any material supplied by or required Amrize, shall be submitted to mediation in Davidson County, Tennessee. In the event that Owner and Amrize do not resolve the dispute, controversy, or claim in mediation, Owner and Amrize agree that neither party will commence or prosecute any suit, proceeding, or claim other than in the state and federal courts located in Davidson County, Tennessee. Each party irrevocably consents to the jurisdiction and venue of the above-identified courts. This Limited Warranty shall be governed by and construed in accordance with the laws of the state of Tennessee without regard to its rules on conflict of laws. Owner hereby releases Amrize from all liability to Owner's insurance carrier or to anyone claiming under or through Owner by reason of subrogation or otherwise.

Waiver & Severability. Amrize's failure to enforce any of the terms or conditions stated herein shall not be construed as a waiver of such provision, or of any other terms and conditions of this Limited Warranty. If any portion of this Limited Warranty is held by a court of competent jurisdiction to be invalid, void, or unenforceable, the remaining provisions shall nevertheless continue in full force.

Eligibility. This Limited Warranty shall be null and void if the product batch numbers submitted with the attached registration are invalid, if the Coating was purchased or installed after its Storage Stability period, or if the Coating is not installed according to the instructions listed on the GacoRoof Product Data Sheet.

AMRIZE DOES NOT WARRANT PRODUCTS INCORPORATED OR UTILIZED IN THIS INSTALLATION THAT WERE NOT FURNISHED BY AMRIZE. AMRIZE SPECIFICALLY DISCLAIMS LIABILITY UNDER ANY THEORY OF LAW ARISING OUT OF THE INSTALLATION OF, PERFORMANCE OF, OR DAMAGES SUSTAINED BY OR CAUSED BY, PRODUCTS NOT FURNISHED BY AMRIZE. THIS LIMITED WARRANTY SUPERSEDES AND IS IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING, WITHOUT LIMITATION, WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE AND AMRIZE HEREBY DISCLAIMS ALL SUCH WARRANTIES. THIS LIMITED WARRANTY SHALL BE OWNER'S SOLE AND EXCLUSIVE REMEDY AGAINST AMRIZE AND AMRIZE SHALL NOT BE LIABLE FOR ANY CONSEQUENTIAL, SPECIAL, INCIDENTAL, OR OTHER DAMAGES INCLUDING, BUT NOT LIMITED TO: LOSS OF PROFITS OR DAMAGES TO THE BUILDING OR ITS CONTENTS, OR THE SUBSTRATE. THIS LIMITED WARRANTY CANNOT BE AMENDED, ALTERED, OR MODIFIED IN ANY WAY EXCEPT IN WRITING SIGNED BY AN AUTHORIZED OFFICER OF AMRIZE. NO OTHER PERSON HAS ANY AUTHORITY TO BIND AMRIZE WITH ANY REPRESENTATION OR WARRANTY WHETHER ORAL OR WRITTEN.
