

## Waterproofing Membrane Compatibility Testing

**Technical Bulletin**

**February 2025**

**GacoPoly™** Quick Grip Low-VOC Drain Mat Bonding Adhesive canister has been tested for compatibility to determine if there would be any adverse effects and/or reactions to the membrane products. For products that are to be applied directly to concrete, the adhesives were applied to the exposed side. For products that would be applied over top of a membrane, the adhesives were applied to the side that would face the membrane. For sheet applied self-adhered membranes, the adhesives were used as a primer, as well as applied over the top of the membrane on the exposed side. The adhesives were applied at approximately 2.5 gm/sq. ft., stored at room temperature for 14 days, and then visually inspected for any changes in the original appearance of the product.
